What is Title I?

Flowery Branch Elementary is identified as a Title I school as part of the Every Student Succeeds Act (ESSA). Title I is designed to support State and local school reform efforts tied to challenging State academic standards in order to improve teaching and learning for students. Title I programs must be based on effective means of improving student achievement and include strategies to support family engagement. All Title I schools must jointly develop with all parents and family members a written parent and family engagement policy.

School Plan for Shared Student Achievement

What is it?

This is a plan that describes how Flowery Branch Elementary will provide opportunities to improve family engagement to support student learning. Flowery Branch Elementary values the contributions and involvement of parents and family members to establish an equal partnership for the common goal of improving student achievement. This plan describes the different ways that Flowery Branch Elementary will support family engagement and how parents can help plan and participate in activities and events to promote student learning at school and at home.

How is it revised?

Flowery Branch Elementary invites all parents to attend an annual parent and family engagement input meeting, in the Spring, to review and revise this parent and family engagement policy, as well as the school/district comprehensive needs assessment, school/ district improvement plans, school-parent compact, and the parent and family engagement budget. Additionally, our school welcomes parent input and comments at any time during the school year regarding this plan. All parent feedback received during the school year will be used to revise the plan for the next school year. The plan is posted on our school website for parents to view and post feedback throughout the year. We also distribute an annual survey online and make paper copies available for their suggestions on the plan and the use of funds for family engagement. Parent and family members can also give feedback during several parent meetings and activities during the school year.

Who is it for?

All students participating in the Title I, Part A program, and their families, are encouraged and invited to fully participate in the opportunities described in this plan. Flowery Branch Elementary will provide full opportunity for the participation of parents and family members with limited English, parents with disabilities, and parents of migratory children.

Where is it available?

At the beginning of the year, after revision, the plan is posted on the school's website, emailed through Remind Message, presented at the Annual Title I meeting, and paper copies are provided in the school's front office.

District Goals 2024-2025

Goal 1: By the end of FY25, the percentage of students in each subgroup moving into the "Proficient" and Distinguished" levels of performance on the Georgia Milestones Assessments will increase by 2% in the "Proficient" and "Distinguished" levels of performance.

Goal 2: By the end of FY25, increase the percentage of referred students who access school based mental health services in order to increase the overall school climate rating for HCSD by 1%.

School Goals 2024-2025

By the end of SY25, the percentage of students in the 41% and above will increase by 3% on MAP Reading and Math on Spring 24 to Spring 25 data.

To increase student engagement, FBES teachers will provide Enrichment clusters to all FBES students ten times during the 24-25 school year.

By the end of the SY25, FBES will decrease physical aggression by 5% during the 24-25 school year.

School-Parent Compacts

As part of this plan, Flowery Branch Elementary and our families will develop a school-parent compact, which is an agreement that parents, teachers, and students will develop together that explains how parents and teachers will work together to make sure all our students reach grade-level standards. The compacts will be reviewed and updated annually based on feedback from parents, students and teachers during the parent input meeting. Parental Involvement Policy

Flowery Branch Elementary will take the following measures to promote and support parents and family members as an important foundation of the school in order to strengthen the school and reach our school goals. The school will ensure that-

- All parents and families are invited to parent involvement meetings throughout the school year.

- Flowery Branch Elementary operates under an open door policy. The principal and assistant principal are always available to meet with parents and families to discuss student concerns, parent concerns, the curriculum, and improvement of programs.
- The Flowery Branch Elementary School Council which includes teachers, parents, administration, and business leaders, reviews school programs and concerns.
- A teacher-student-parent compact outlines how teachers, parents, and students will share the responsibility for improved student achievement. Results of academic assessments are shared with parents and students.
- School personnel will provide assistance to parents and families in understanding state academic standards and state and local assessments.
- The school counselor assists parents and families in understanding student services offered through the school system and in the community that may help meet specific student or family needs.
- Parent involvement programs for parents and families are offered by the parent liaison.
- Partner with Head Start through the District Parent Outreach Facilitator. The District Parent Outreach Facilitator meets with parents and families providing information and resources to support school orientation for parents, families and students to assist in successful student transitions to kindergarten.
